

### **Our Foundation**

At the heart of our Foundation is our Public Policy Fellowship program, which has been running for 18 years. During this time, 326 Fellows have worked with public interest organizations and government offices in the US and across the world.

#### In 2022, the Foundation had 28 Fellows.

Three were our Racial Justice Fellows, two were Disaster Relief in Puerto Rico Fellows, one was our first Veterans Justice Fellow, and 22 were Public Policy Fellows.

Together with the Deans and senior representatives from our Fellowship law schools, we pursue our commitment to engaging, inspiring and supporting law students to be the next generation of public interest advocates.

### The Deans' Circle

The Foundation's partnership with the Deans' Circle continues to invigorate our program and promote public interest advocacy by our Fellows.

Building on its contributions to the creation of the Sustained Impact Fellowship program, the Deans' Circle was instrumental to the formation of the Veterans' Justice Fellowship. It also provides valuable overall quidance for the Fellowship program. This year, the Deans' Circle served as a forum for presentations and discussions including on the war in Ukraine (Ambassador Frank Wisner), trends in philanthropy (PNC Philanthropy Director Avery Fontaine), and "The First Amendment on Campus" (Steve Dunham, then General Counsel at Penn State University).

### **Foundation Fellowship Programs**

#### **Racial Justice Sustained Impact Fellowship Program**

In the aftermath of the murder of George Floyd, the Foundation established three Fellowships focused on racial justice in the areas of police/Minority Community Relations, juvenile justice reform in minority areas, and voting rights. These are Sustained Impact Fellowships that will continue.

In 2022, the Foundation partnered with the Citizen Complaint Authority in Cincinnati, the Lone Star Justice Alliance in Dallas, and the voting rights project at the Lawyers' Committee for Civil Rights in Washington. Our Racial Justice Fellows were, respectively, Kaitlyn Naylor (SMU Dedman School of Law), Marcus Montgomery (University of Arkansas School of Law) and Abigail Lola Young (University of Miami School of Law).



#### **Disaster Relief Sustained Impact Program in Puerto Rico**



In our fourth year with Ayuda Legal and Centro Para Puerto Rico, Foundation Fellows continue to address the damage from Hurricane Maria and subsequent natural disasters in Puerto Rico. This year's Fellows Andi Dorning (University of Cincinnati College of Law) and Dori Butler (Georgia State University College of Law) did so, with a highlight on racial disparity in the allocation of disaster relief funds and access to justice issues.

#### **Veterans' Justice Sustained Impact Fellowship Program**



In 2022 we inaugurated the Veterans' Justice Sustained Impact Fellowship, in which a Fellow is selected to work with Swords to Plowshares, a San Francisco Bay-area organization that provides legal and other support to homeless veterans who are facing difficulties receiving veterans' benefits.

The first such Fellowship was awarded to Josh Clem, a six-year U.S. Marine Corps veteran who is a student at the University of Arkansas School of Law. Speaking at our Veterans Day event, Josh described the Fellowship as "an opportunity to give a voice to a community that I 100% identify with."

#### **Public Policy Fellowships**

The backbone of the Fellowship Program has long been our Public Policy Fellowship Program. Each year the Deans' Circle law schools' nominations for the Public Policy Fellowship Program are a unique blend of talented law students who bring a passion for public service directed at the country's most pressing issues. The Class of 2022 Public Policy Fellows worked on a wide range of issues, including geo-political topics concerning Ukraine and Europe, access to justice, criminal justice, environmental issues, international development, consumer protection, housing justice, immigration, disability and mental health advocacy, and racial justice.

### **Honors for Our Chairman**

In September, the Arkansas Bar Association inducted Rodney Slater into its inaugural Hall of Fame class. John Oberdorfer, Arkansas Law Dean Cynthia Nance, Fellows Marcus Montgomery, Lexi Robertson, Josh Clem and Andrew Humphrey celebrated the occasion with Rodney.








### **The Foundation Celebrates Veterans Day**

For the last two years, the Foundation has hosted Veterans Day programs to provide our veteran Fellows an opportunity to speak about their own experiences and the legal and other issues faced by veterans as they transition to civilian life. Rick Talisman, Chair of the Foundation's Advisory Committee, moderated this second celebration by the Foundation.











General Wesley Clark, former Supreme Allied Commander, Europe, presented a special message commending all the Veterans in the firm, the 20 Fellows who are Veterans, and the Foundation's Veterans Justice Fellowship partnership with Swords to Plowshares.

We were honored to hear from three 2022 Fellows and veterans – Josh Clem, Michael Pruitt and Mark Dela Peña. They spoke about their experiences in the military, how that informed their decisions to go to law school, and what they already have accomplished and hope to do going forward.

Maureen "Mo" Seidor and Rose Goldberg were also featured. Mo is the Legal Director of Swords to Plowshares, the Foundation's partner for the Veterans' Justice Sustained Impact Fellowship and the organization where Josh Clem served his Fellowship this summer. Rose was instrumental in the formation of the Foundation's partnership with Swords to Plowshares. She received the Foundation's 2014 Distinguished Fellowship Award, has started several veterans organizations and teaches Veterans Law at the UC Berkeley School of Law.

### **Foundation History**

The Foundation was established in 2000, endowed with the firm's awarded lawyers' fees from the *Ironworkers pro bono* case. In that case, won by Foundation President John Oberdorfer and others, a federal court in Washington DC struck down racial barriers to union membership faced by African American construction workers building the Washington DC Metrorail system.

2000	Foundation established in honor of Jim Patton at the time of his retirement.
2004	Foundation establishes the Public Policy Fellowship program.
2005	Foundation awards first Public Policy Fellowships to students at the Georgetown University Law Center, The George Washington University Law School, the University of Virginia School of Law and the Southern Methodist University Dedman School of Law. Foundation establishes the Foundation's Advisory Committee.
2010	First "Issues of OurTime" lecture event. Speakers since have included Ambassador FrankWisner, international affairs advisor at Squire Patton Boggs; former EU Ambassador to the US David O'Sullivan; and historian/author Lynne Olson.
2012	The 100th law student participates in the Public Policy Fellowship program.
2013	Public Policy Fellowship grows to 15 law schools. International Fellowship program begins with Qatar law student awarded fellowship.
2015	Foundation adds Fellowships at the law schools at Case Western Reserve and the University of California at Hastings.
2016	Distinguished Fellows Award created. Qatar Ambassador and Fellows from Qatar honored in Washington. US Ambassador honors 2016 Qatar Fellow in Doha. Foundation hosts symposium on combating poverty.

2017	Expansion of Fellowship program to law schools at the University of Miami and The Ohio State University. 200th law student participates in Fellowship program. "Foundation Moments" established.
2018	Formation of the Deans' Circle. Expansion of Fellowship program to Europe at Collège d'Europe. Welcomes University of Arkansas School of Law to the Fellowship program.
